Discussion over Agendas:

2.1 Financial activities from the Treasurer:

The Treasurer submitted the financial reports of the 12th AGM and Election. After a comprehensive discussion, the executive board unanimously approved it. The approved balance sheet is attached as Annex-I (see Annex I).

2.2 Payment of membership fees to NRNA ICC:

The Executive Board approved the payment of USD 76,630.00 to the ICC. This amount represents membership dues of USD 5/member for a total of 15,326 members, including life members, as per NRNA-NCC USA's bylaws.

2.3 Refund of overpaid candidacy fees of chapter candidates in elections:

The Executive Board decided to refund the overpaid candidacy fees to all chapter candidates who overpaid before the Election Commission reduced the candidacy fees for chapter candidates.

2.4 Nomination fee for vacancies in various chapters:

The Executive Board authorized the chapters to fill vacant positions and determine the candidacy fees. The chapters can retain the collected candidacy fees; however, they must inform the NCC Executive Board about the collected fees and the names of the positions being filled.



2.5 Disbursement of Membership Dues of Chapters' portion to the Chapters:

The Executive Board approved the disbursement of the chapters' portion of membership dues as soon as possible, as per the Bylaws of NRNA, NCC-USA.

2.6 Delegates for the upcoming World Conference of ICC:

The Executive Board decided to form an ICC delegates committee, under the chairmanship of the Senior Vicepresident including all Vice-presidents, and the General Secretary. The committee is authorized to appoint other committee members from the NCC Board, Regional Committee, and the Chapters as needed.
