Note: this calendar may be changed, adjourned, and or extended exclusively by the “Election Board” pursuant to the authority granted under all applicable provisions of NRNA NCC USA Bylaws 2010 with the amendments 2022 (“Bylaws”), including Article XVI, Sections (Sections 108-153, hereinafter, Sec. 108-153). Please also refer to Schedules 1, 2, and 3 of the NRNA USA Bylaws (“Bylaws”).

June 22, 2023: Initial** Publication of voters list *TO BE SHARED* to NRNA NCC USA MEMBERS THROUGH <https://www.nrnusa.org/> based on **“AS IS”** data provided **TO ELECTION BOARD by the ICC ON June 21, 2023.** To meet a minimum of 30 days before nomination scheduling call-up dates under the bylaws, the voter’s list shall be published (***UPON A FURTHER condition that a full FINAL list of NRNA NCC USA Membership/VOTERS LIST CONTAINING ALL REQUIRED INFORMATION SHALL BE provided by the ICC TO THE ELECTION BOARD WITHOUT ANY RESTRICTION OR RESERVATION AND OR LIMITATIONS TO THE ELECTION BOARD BEFORE PUBLICATIONS OF ANY OR ALL FINAL VOTERS LIST.***) (Note: any complaint regarding the voters’ list MUST be submitted (with valid proof and ID) in writing to Election Board on or before *June 25th, 2023, by noon EST* at: Electioncommission2023@nrnusa.org
- 2. June 25TH, 2023 AFTER 6 PM EST** - Final list of Voters [*PLEASE REFER TO AN ATTACHED CONDITION AS MENTIONED ABOVE, SEC-1*]
- 3. June 27th-28TH, 2023**--Filing of Candidates’ Nominations by noon (12 PM) EST.
- 4. July 3RD, 2023** –Initial Candidates list publication

7. **July 9th, 2023-** by noon (12 PM) EST – Withdrawal of any Candidacy

8. **July 11, 2023--**Final Candidates list publication

9. **July 22nd, 2023--July 23rd, 2023—Election Starting 8 AM EST (July 22)–Election Ending 8 AM EST (July 23) - Election Dates**

10. **July 24, 2023** – Final Election Results

11. **TBD (at the end of July 2023):** Certificate and oath, Handover Ceremony
