# Opening of the meeting:

The President, opening the session, brief his tour regards and thanked the board for running the organization smoothly in his absence. The President also mentioned and appreciated for forming the Continuation of Nepali Citizenship Lobbyist Committee, and other appropriate actions were taken regarding CNC. Moreover, he emphasized, what issue should the CNC Lobbyist Committee

strongly raise? He said, "we should stick to the point: all other privileges should be awarded to the Non-Resident Nepali Citizenship holders, other than the political rights that are awarded to other kinds of citizenships." Furthermore, the President condemned the Colorado incident and gave authority to the General Secretary to move the meeting forward.

On the authority of President, the General Secretary moved the meeting forward and tabled the agendas respectively.

#### • Colorado Incident.

Moving the agenda forward, the General Secretary asked the Colorado Chapter President, Mr. Raj Dhungana, to brief regarding Colorado Incident, where a Nepali Origin Birendra Thakuri had been fatally shot by Westminster Police on 25th Aug 2018. Mr. Raj Dhunghana then updated us regarding the incident and the ongoing legal process. After listening to him, the Executive Board expressed their condemnation, paid tribute to the deceased, and expressed their condolences to the bereaved family. Moreover, the Board thanked all community leaders and local organizations, including the NRNA NCC and the USA's Colorado Chapter, for playing a vital role in bringing the incident under the process of legal justice.

#### • Funding Authorization (front money) for the CNC Committee.

Moving the agenda, the General Secretary explained that the "Continuation of Nepali Citizenship Committee" has submitted the funding requisition application to the Board (please see the attached document, herewith Annex I, for more info) and that the General Secretary had requested that NRNA ICC provide the funds, claiming that the CNC's issue is standard issue affecting all NRNs around the world (please see the attached document, herewith Annex II, for more info). However, the ICC has denied the request, citing several reasons (please see the attached document, herewith Annex III, for more info). The General Secretary

then said, "On the authority of the President, I (the General Secretary), move this motion to pass the front money and deploy the officials for the mission."

After a brief discussion, the Board unanimously passed the agenda and authorized funds of US\$10K as front money, which has to be cleared immediately after the mission's return, invoices and receipts must be submitted when clearing the front money, invoices and receipts other than those for the stipulated purpose will not be considered as official expenses and will be subject to repayment.

Authorized advanced payment funds can only be used for the following purposes:

- Work with CNC Task Force NRNA to organize meetings and forums with elected members and government officials to educate them about our concerns.
- 2. Consultation expenses.
- 3. Meeting and documentation expenses

Furthermore, the board deployed Mr. Jedu Pokharel, Regional Vice-President, and Mr. Sanjay Thapa, BOD, for the mission.

At the end of the meeting, the General Secretary requested that the Board skip the upcoming regular meeting scheduled for the 2nd of September 2018, citing that "We have already had three meeting within a month," and the Board voted to skip it. Likewise, the president adjourned the meeting extending thanks to all participants.

#### Funding Requisition From NRNA NCC USA, CNC Committee

Dear Mr. President,

The meeting of the CNC lobbyist committee held on 8/19/2018 discussed latest amendments submitted and found that some more changes need to be added to the proposed amendment. Especially adding provisions to discourage different interpretation of the laws by private individuals or organizations and how to safeguard those behaviors. Another point discussed was to replace text in appropriate place to say, " all rights except political in par with citizens of Nepal".

The committed members think that meeting the lawmakers (policy makers) in person and putting our concern to them directly may bring the desired change on the proposed amendments. Given the importance of the laws and amendments put forward (in the legislative body and different committees) and also the role that NRNA NCC of USA has played, historically in this matter, the committee thinks a visit by a small group of people to Nepal to work with the elected members and government officials and educate them on the issues mentioned above and others would be beneficial to the member of diaspora hear in the US as well as in Nepal.

The meeting of the CNC lobbyist committee held on 8/19/2018 has decided to request NRNA NCC of USA to provide fund of amount \$10,000.00 for the following purpose:

- (1) Work with CNC Task Force NRNA to organize meetings and forums with elected members and government officials and educate them on our concerns
- (2) Consultation expenses
- (3) Meeting and documentation expenses

Dear Sir,

As we are all aware, the Nepal Government is submitting the Citizenship Bill to Parliament, and the bill does not correctly address Non-Resident Nepali (NRN) citizenship; in particular, the requirement of the submission of proof of relinquishment of Nepali citizenship to apply for NRN citizenship is against the spirit of the Constitution regarding NRN citizenship. We, NRNA NCC USA, have formed the CNC Lobbyist Committee to lobby for the amendment of the bill. The Committee has requested us to provide USD 10-15k for a small group of people to visit Nepal to work with the elected members and government officials and educate them on our issue. Since it is our standard issue, we kindly request you to authorize \$10k for the task mentioned above.

#### **Response from ICC**

Dear Baburam ji! Namaskar.

Yes, definitely now the Citizenship bill is in Parliament now. The bill does not correctly address various issues of NRNs. The CNC task force (Continuity of Nepali Citizenship) in the leadership of Patron Ram P. Thapa is working on it in the micro level. NRNA had collected all the shortfalls and collectively pursuing in various level. Now, the state management committee has to be formed soon where the citizenship bill will be discussed and suggestion will be sent to parliament. Yes of course we need to push this issue collectively and every NRNs who have their connection with parliament members and especially with the State Management Committee of the parliament need to pursue this issue.

As per the NRN regulations, every task force and Committee is managing the necessary funds themselves using the large NRNA Diaspora. So, the CNC task force is also managing it's fund itself. This is the right and high time to lobby and I request every NCC to participate financially too. I regret that ICC does not have any particular fund for that. So, I request NCC USA to approach with every state committee, individual members and other possibilities to collect the necessary funds to lobby and help CNC committee for the same.
